



At 1450 hours, Chief Lindsey and myself made contact with Crow. Chief Lindsey asked if Compton had a work area in the building. Crow stated that he had a small office in the girl's locker room in the basement of the high school gymnasium. We asked for consent to search his office. Crow advised that we could. At 1520 hours, Chief Lindsey and myself began our search of Compton's office area. ( SEE REPORT # 2011-494 FOR ITEMS FOUND )

On 11-18-2011 at 0900 hours, Fowler, Chief Lindsey and myself met with [redacted]. Fowler conducted the interview with [redacted]. During the interview, Fowler had [redacted] describe the incident that had occurred. [redacted] went on to say that towards the end of class, Coach Compton was sitting [redacted] next to the score table. This was when Compton removed a cell phone from his pocket and said " look at this ". Fowler at this time had [redacted] describe what [redacted] saw. [redacted] stated that [redacted] observed two pictures of a hard penis, no faces in picture, taken from what looked like a top angle photo. [redacted] also stated that it appeared there were blue bed sheets under the penis. [redacted] stated that [redacted] observed three other pictures which [redacted] described as " porn stars ". [redacted] describe the women as bent over showing their butts and had large breast.

Fowler asked [redacted] what [redacted] did after the pictures had been showed to [redacted] stated [redacted] closed the phone and Coach Compton took the phone back. [redacted] stated that Coach Compton told [redacted] that's my phone and don't tell anyone about what you saw. Fowler asked how this made [redacted] feel. [redacted] stated it made [redacted] feel uncomfortable and scared. [redacted] stated that after it happened, Compton kept looking at [redacted] as if he was trying to get a response out of [redacted] stated that the bell rang for class to be released ;

Fowler asked what happened next. [redacted] stated that [redacted] told a friend what had occurred and they went and spoke with a teacher about the incident. During another part of the interview, Fowler asked [redacted] if Coach Compton ever made [redacted] feel uncomfortable before this incident. [redacted] stated he did make [redacted] feel uncomfortable and has " rubbed " [redacted] shoulders about a month ago that made [redacted] feel uncomfortable. [redacted] also stated that [redacted] freshman year, Coach Compton made a comment about boobs and the shirts that [redacted] wears. [redacted] describe that Compton said " boys will get the wrong idea of you because of the shirts you wear, you can see your boobs ". [redacted] provided a hand written statement about what had occurred.

On 11-18-2011 at 1300 hours, Chief Lindsey and myself met with Compton at the police department. Chief Lindsey advised Compton that we would like to speak him about an incident but was free to leave at anytime. Compton stated he understood and agreed to speak with us. Chief Lindsey asked Compton if he knew why we wanted to speak with him. Compton stated " yes, its about what happened at Licking

High School with a phone and student seeing images". During the interview, Compton gave his side of the story. Compton stated he had found a black track phone after one of his classes. Compton stated he put the phone in his pocket and went to his class. Compton stated that during the class, he took the phone out of his pocket to try and figure out who's it was. Compton stated that his [redacted] kept asking him a bunch of questions about who's phone it was. Compton stated at this time, [redacted] took the phone away from his hands and began to look at it. Compton stated he looked at [redacted] trying to figure out what [redacted] was doing and it looked like [redacted] was gonna try and take a picture of something. Compton stated that [redacted] closed the phone and he snatched it back from [redacted] and became more interested in who's phone it was. Compton stated to "get [redacted] to shut up" he told [redacted] that it was his and to just drop it. Compton went on to say that he should have never let [redacted] look through the phone and took the phone to Denbow. Chief Lindsey ask where the phone was and he stated "I freaked out and threw it out my vehicle window on the way to class in Rolla". It should be noted that Compton stated he has no feeling towards [redacted] and did not show any pictures intentionally. Chief Lindsey asked about the magazines and he stated "there my magazines and it has nothing to do with showing a picture to someone".
